## Neighborhood Crime Breakdown, August 2020

Reporting Period: 01 July 2020 through 31 July 2020

### Part 1 offense reports

In July 2020, local police recorded ten (10) Part 1 offense reports within the boundaries of TCA. Of these reports, six (6) detailed were theft-from-auto incidents occurring entirely within a 10-day timespan from July 12 until the morning of July 21. At least two of these theft-from-auto incidents (containing a total of 4 reported targeted vehicles on Stanley Avenue, Henry Road, Thornden Road, and Rockland Pike) appear related, having all occurred in close proximity and sometime during the night of July 12 into July 13. The remaining four reports on Debeck Drive, Pier Drive, Marcia Lane, and Ardennes Avenue, appear more disconnected over time (all are more than 1 day apart) and more geographically distant.

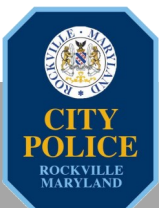
Local police also made one arrest for a robbery that occurred at a bus stop at 1800 Veirs Mill Road during the evening of July 8.

Police also recorded three additional thefts scattered throughout the month. One theft was of prescription medication within a home, and two were reports of items—two unsecured bicycles in one report and a secured backpack blower in another—stolen from residents' yards during late night hours.

### Part 2 offense reports

Local police also recorded nine (9) Part 2 offenses, to include six (6) vandalism cases, 1 non-fatal drug overdose, 1 domestic simple assault, and 1 trespassing case.

Two sets of vandalism cases appear related: in one set of cases, an unknown and unprovoked subject (or group of subjects) is recorded as repeatedly damaging various building windows. In the other set, two separate residents on Meadow Hall Drive reported that a group of intoxicated and disorderly individuals were damaging vehicle mirrors.

## Calls for Service Trends

We recorded 63 calls for service linked to within the boundaries of TCA in July 2020, a typical amount when compared to a historic average of 70 calls per 31-day period (note that previous reports had included calls about animal control and non-criminal matters, and this report now excludes them). This figure is in the top 37% of historic monthly call volume.

In July, the only call category to be significantly above average (or above average generally) was larceny, which historically averages 6 calls per month. Meanwhile, we recorded no calls about alarms— which average 4 per month— and significantly fewer calls concerning suspicious activity, which average 19 per month. All other call categories were at or near their typical levels.
