Neighborhood Crime Breakdown, July 2022

Reporting Period: 01 June 2022 through 30 June 2022

Part 1 offense reports

In June 2022 and within the boundaries of Twinbrook Community Association (TCA), Rockville City (RCPD) and Montgomery County police (MCPD) together recorded eleven (11) reports of Part 1 offenses, to include:

- ⇒ One (1) case of aggravated assault between a man an his wife
- ⇒ One (1) residential burglary when an intoxicated man seeking rest and was spotted forcing his way into a condemned shed in the 5900 block of Coral Sea Avenue
- \Rightarrow Six (6) thefts from auto:
 - ⇒ Overnight from June 21-22, an unknown person stole a variety of goods from within two unlocked cars in the 5800 block of Wainwright Avenue and 5900 block of Ridgway Avenue. About five days later, an additional two residents in the 1600 block of Gruenther Avenue and 1700 block of Farragut Avenue found that someone had also stolen items from with their unlocked cars in the early morning hours of June 27. One additional complainant in the 300 block of Dean Drive found that someone had stolen the nuts and bolts from his car in about the same timeframe
 - Additionally, a woman spotted her ex-boyfriend removing her rear license plate during the afternoon of June 03
- ⇒ Two (2) motor vehicle thefts, first amidst a dispute between a former couple and then when an employee of a business failed to return a car transferred to him. The latter suspect eventually admitted that his 14-year-old son took the vehicle and was involved in a hit-and-run
- ⇒ One (1) additional theft involving stolen medication by a visitor to a family's home

Part 2 offense reports

RCPD and MCPD recorded together reported eight (8) Part 2 offenses within TCA in June, including two (2) domestic simple assaults, two (2) drug violations ending in an overdose, one (1) DUI, two (2) reports of graffiti found in a park, and a violation of court order.



Calls for Service Trends

Calls for service within TCA amounted to 79 calls in June 2022, representing a highly elevated volume in the top 93% of historical monthly call data here.

Calls concerning disorder offenses (in this case, for assault, public drunkenness, DUI, vandalism, and disorderly conduct), larceny & burglary, and suspicious activity were all recorded at a significantly high volume. In the past few years, these call categories have averaged 15, 7, and 13 calls per month respectively.

Readers should note that calls described here may ultimately result in reports describing an incident outside the TCA boundaries, or outside this reporting period. Below one can find a table describing the disposition of calls by category:
