Neighborhood Crime Breakdown, August 2021

Reporting Period: 01 July 2021 through 31 July 2021

## Part 1 offense reports

In July 2021, Rockville City (RCPD) and Montgomery County (MCPD) police together recorded thirteen (13) cases of Part 1 offenses within the boundaries of Twinbrook Community Association (TCA), including:

- ⇒ Nine (9) reports of theft-from-auto: of these July incidents, seven (7) occurred sometime after the afternoon of July 20. These thefts tended toward the southwest border of Twinbrook, as six (6) of them were reported between Lewis Avenue in the southwest and Crawford Drive or Ardennes Avenue in the north and northeast. In all but one report, the suspects stole personal property from within the victim's car (the other report targeted the vehicle's airbag). In seven of these nine thefts the thieves acted sometime overnight and, in one additional case, the victim reported that the theft could've occurred anytime over several days
- ⇒ Two (2) reports of auto theft, both of which appear disconnected: in one case, a resident reported that her 15-year-old foster son took her vehicle without permission and, in the other case, the perpetrator(s) stole an unsecured vehicle on the 1600 block of Bradley Avenue overnight between July 25 and July 26
- ⇒ One (1) report of burglary, where the perpetrator targeted a resident's storage shed for landscaping tools on July 09 at multiple times from 0206 to 0223
- $\Rightarrow$  One (1) report of theft reported between two friends engaged in a verbal a dispute

## Part 2 offense reports

RCPD and MCPD officers recorded six (6) instances of Part 2 offenses occurring within the boundaries of TCA, including:

- $\Rightarrow$  Two (2) cases of vandalism, including one case targeting a woman's tires
- $\Rightarrow$  Three (3) separate cases of simple domestic assault
- $\Rightarrow$  One (1) case of a drug overdose



## Calls for Service Trends

Dispatchers recorded 77 calls for service within the boundaries of TCA in July 2021, rising to a slightly elevated amount compared to its historic average of 69 calls per (31 day) month. July's call count is in the top 73% of historic monthly TCA call volume.

Of the categories listed below, calls about property crime other than larceny and suspicious activity were both at an usually high volume. Of these property crime reports, one was confirmed as a residential burglary and two as motor vehicle thefts (all described on page 1) while remaining cases include one case of credit card fraud and two cases of scams or embezzlement.

Meanwhile, all verified calls of suspicious activity occurred on separate nights, except for the following:

- ⇒ July 10: two verified calls of suspicious activity, one on the 1300 block of Crawford Drive and one 0.40 miles away on the 13300 block of Midway Avenue
- $\Rightarrow$  July 29: three verified calls at the same address on the 1300 block of Matthews Drive
- ⇒ July 30: two verified calls, one on the 1000 block of Lewis Avenue and another 0.54 miles away on the 1600 block of Crawford Drive

All call categories were near or well below their historic monthly average. Readers should note that calls described here may ultimately result in reports describing an incident outside the TCA boundaries, or outside this reporting period. Below one can find a table describing the disposition of calls by category:
