## Neighborhood Crime Breakdown, December 2021

Reporting Period: 01 November 2021 through 30 November 2021

#### Part 1 offense reports

In November 2021, Rockville City (RCPD) and Montgomery County (MCPD) police together recorded three (3) Part 1 reports within the boundaries of Twinbrook Community Association (TCA), all of which were thefts-from-auto:

- ⇒ Unit block Rosanne Lane: last seeing his pickup truck undisturbed on the street on November 05 at 8:00 p.m., a resident returned the next day at 9:00 p.m. to find a valuable sum of power tools missing from his open trunk bed.
- ⇒ 1600 block Lewis Avenue: a resident witnessed a woman enter his vehicle on November 13 at 9:10 p.m., but she fled when he called out to her.
- ⇒ 1600 block Crawford Drive: a resident reported that someone had rummaged through his vehicle without forced entry sometime between November 27 at 6:00 p.m. and 10:30 a.m. the next day, but took nothing.

### Part 2 offense reports

Excluding an unfounded weapons violation case, in November 2021 RPCD and MCPD together recorded four (4) Part 2 reports, including a simple assault, two reports of vandalism—one a result of a domestic dispute and the other targeting City property— and one case of a shooting.

- ⇒ The simple assault referred to a minor altercation between two subjects in a home and one of whom reported symptoms of depression. Neither parties reportedly wished to pursue charges.
- ⇒ In the shooting case, occurring on the 500 block of Dean Drive on November 16 around 8:42 p.m., surveillance footage shows that someone fired 3 gunshots from the driver's side window of a car before speeding off. RCPD detectives are conducting an investigation.



#### Calls for Service Trends

Calls for service within TCA plummeted to 44 calls in November 2021, an extremely subdued amount compared to TCA's historic average of 67 calls per (30 day) month. November's call count is in the bottom 6% of historic monthly TCA call volume.

All call categories were near or well below their historic monthly average.

Readers should note that calls described here may ultimately result in reports describing an incident outside the TCA boundaries, or outside this reporting period.
