Neighborhood Crime Breakdown, November 2021

Reporting Period: 01 October 2021 through 31 October 2021

Part 1 offense reports

In October 2021, Rockville City and Montgomery County police together recorded six (6) cases of Part 1 offenses within the boundaries of Twinbrook Community Association (TCA), including:

- ⇒ Two (2) reports of residential burglary. The first case occurred at an unoccupied home the 300 block of Gruenther Avenue on the evening of 10/13-10/14 via forced entry, but with nothing stolen. In the second case, occurring soon after midnight on 10/20, a woman spotted a man in her home on 800 block of Gail Avenue, entering without force and who fled on sight. Police deployed, set up a perimeter, and dispatched a K9 track, but could not find the intruder
- ⇒ Two (2) reports of theft-from-auto overnight, the first occurring on the 1700 block of Crawford Drive on 10/12-10/13 to an unlocked vehicle and the other occurring 0.38 miles southwest on 10/17-10/18 via unknown means
- ⇒ Two (2) reports of theft, both citing the same suspect living at a home on the 1000 block of Paul Drive and including the theft of a rental scooter past its rental period and the theft of cash from a roommate's bedroom

Part 2 offense reports

RCPD and MCPD officers recorded seven (7) instances of Part 2 offenses occurring within the boundaries of TCA in October, including (3) cases of simple domestic assault, two (2) cases of DUI, one (1) case of marijuana possession, and one (1) case of graffiti and at public park.



Calls for Service Trends

Calls for service within TCA rose to 77 calls in October 2021, a slightly elevated amount compared to TCA's historic average of 69 calls per (31 day) month. October's call count is in the top 73% of historic monthly TCA call volume.

Of the categories listed below, calls about property other than larceny and suspicious activity were both recorded at an unusually high volume. These calls of property crime refer to two cases of identity theft, one case of counterfeit checks, and the two cases of residential burglary mentioned on page 1.

All other call categories were near or well below their historic monthly average. Readers should note that calls described here may ultimately result in reports describing an incident outside the TCA boundaries, or outside this reporting period.
