Neighborhood Crime Breakdown, October 2021

Reporting Period: 01 September 2021 through September 2021

Part 1 offense reports

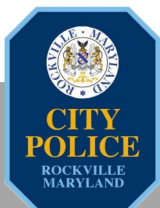
In September 2021, Rockville City (RCPD) and Montgomery County (MCPD) police together recorded seven (7) cases of Part 1 offenses within the boundaries of Twinbrook Community Association (TCA), including:

- ⇒ One (1) report of a theft-of-auto-part (other than license plates), detailing the theft of a catalytic converter stolen sometime between 09/04 and 09/25 at a home on the 1900 block of Lewis Avenue. As is typical of these offenses, perpetrator(s) targeted a mid-2000s Toyota Prius.
- ⇒ Two (2) reports of burglary and (1) motor vehicle theft: a Twinbrook resident heard noises outside her home on 09/14 at 0100 and witnessed a man attempting to open her back door. This man fled in a car when she turned on her home lights. Soon thereafter, an MSP trooper witnessed a similar car flee a traffic stop and local officers then discovered that someone had stolen the house keys and key fobs to two vehicles from an unlocked home on Pier Drive.
- ⇒ One (1) report of motor vehicle theft: a resident living on the 1700 block of Grandin Avenue reported that upon parking his Kawasaki dirt bike on the evening of 09/07, he found it gone the following morning. This case appears similar to five other nearby motorcycle thefts reported between 09/07 and 10/03 (although only this case fell within the TCA boundaries).
- ⇒ One (1) report of a theft-from-auto, denoting the theft of a designer wallet from a vehicle parked on the 300 block of Dean Drive during the evening of 09/01 into the morning of 09/02.
- ⇒ One (1) report of a theft-from-a-building referring to the theft of cash between two family members and referred to MCPD's Special Victims investigation unit.

Part 2 offense reports

RCPD and MCPD officers recorded six (6) instances of Part 2 offenses occurring within the boundaries of TCA in September, including one (1) case of harassing phone calls and four (4) reports of simple assault, three of which were domestic and one was a case of road-rage.

RCPD officers are also investigated one (1) weapons violation at the intersection of Calvin Lane & Dean Drive in which the occupants of a vehicle shot a firearm into the air, but injured no one and damaged no property.

Calls for Service Trends

Calls for service within TCA declined to 71 calls in September 2021, a typical amount compared to TCA's historic average of 66 calls per (30 day) month. September's call count is in the top 67% of historic monthly TCA call volume.

Of the categories listed below, calls about property other than larceny and violent crime were both recorded at an usually high volume:

- ⇒ These calls of property crime refer to the burglary and motor vehicle theft cases mentioned on the previous page, two cases of forgery/counterfeiting/identity theft, and one case describing a recovered vehicle stolen in Gaithersburg but recovered on Crawford Drive.
- ⇒ The six violent crime calls refer to the four simple assault cases and weapons violation described on the previous page, plus an assault that had occurred in Silver Spring.

All call categories were near or well below their historic monthly average. Readers should note that calls described here may ultimately result in reports describing an incident outside the TCA boundaries, or outside this reporting period.
